
GENERAL ORDER NO. 102


In the interest of justice and to the benefit of those persons and agencies served by this office, the Court authorizes the consolidation of clerical and administrative functions required for the management of the Central Violation Bureau for the Eastern District of California at Sacramento with the automated Courtran Central Violation Bureau for the Central District of California at Los Angeles.


Persons charged with violation of any offense listed in the Appendix hereto not designated as requiring a court appearance may, in lieu of appearance, post collateral in the amount indicated for the offense, waive appearance before a magistrate, and consent to forfeiture of collateral. Persons charged with offenses indicated in the attached Appendix as requiring a court appearance or with offenses not listed therein must appear for trial as in the case of other petty offenses.

This Order shall become effective July 1, 1981.


