


Said United States Magistrates shall enter upon the performance of their duties at 12:01 a.m. on May 1, 1971, but, prior to the commencement of such duties shall take the oath or affirmation prescribed by 28 U.S.C., sections 453 and 631(f).


The said part-time United States Magistrates are to hold and discharge the duties of said office for a term of four (4) years from the 1st day of May, 1971, unless sooner removed, subject to the provisions of 28 U.S.C., Section 631(c).

The said full-time United States Magistrate is to hold and discharge the duties of said office for a term of eight (8) years from the 1st day of May, 1971, unless sooner removed, subject to the provisions of 28 U.S.C., section 631(c).

The Clerk will cause a certified copy of this order to be spread upon the records of this court at Fresno, California, and shall likewise forward a certified copy of said order to the Director of the Administrative Office of the United States Courts as required by 28 U.S.C., section 631(g).
