4 AMENDMENT TO AMENDED PLAN FOR THE  
5 RANDOM SELECTION OF GRAND AND PETIT JURORS

6 Pursuant to the Jury Selection and Service Act of 1968, as amended (28 U.S.C. § 1861, et  
7 seq.), the following Amendment to the Amended Plan filed March 11, 1992, is hereby adopted by  
8 this Court, subject to approval by the reviewing panel for the Ninth Circuit and to such rules and  
9 regulations as may be adopted from time to time by the Judicial Conference of the United States:

12 AMENDMENT TO ARTICLE XVII, FREQUENCY OF SERVICE

13 Article XVII, Frequency of Service is amended by adding thereto the following:

14 A petit juror required to attend more than ten days in hearing one case may be paid, in the  
15 discretion of the trial judge, an additional fee, not exceeding \$10 more than the attendance fee, for  
16 each day in excess of ten days on which the juror is required to hear such case.

17 A grand juror required to attend more than forty-five days of actual service may be paid, in  
18 the discretion of the district judge in charge of the particular grand jury, an additional fee, not  
19 exceeding \$10 more than the attendance fee, for each day in excess of forty-five days of actual  
20 service.

21 A grand or petit juror required to attend more than ten days of actual service may be paid, in  
22 the discretion of the judge, the appropriate fees at the end of the first ten days and at the end of every  
23 ten days of service thereafter.

24 Certification of additional attendance fees may be ordered by the judge to be made effective  
25 commencing on the first day of extended service, without reference to the date of such certification.
