GENERAL ORDER NO. C

ORDER CONTINUING AUTHORITY
OF UNITED STATES COMMISSIONERS
AND THEIR EMPLOYEES, NORTHERN
DIVISION

WHEREAS, by Public Law 89-372, 89th Congress, S. 1666, March 18, 1966, the Congress of the United States created the Eastern District of California out of the Northern Division of the Southern District of California and a portion of the Northern Division of the Northern District of California as it existed prior to the effective date of said Act; and

WHEREAS, until further order of this Court it is intended that all United States Commissioners appointed and acting in the said Northern Division of the Northern District of California as of the effective day of said Act, should continue to function as United States Commissioners for the Northern Division of the Northern District of California in all matters still pending in the United States District Court for the Northern Division of the Northern District of California as of the effective date of said Act;

IT IS HEREBY ORDERED that all United States Commissioners in and for the Northern Division of the Northern District of California holding office immediately prior to the effective date of the aforementioned Act, are hereby continued in their respective offices for the United States District Court, Northern District of California,

Northern Division, for the purpose of performing such duties as may devolve upon them for the Northern District of California, Northern Division, as it existed prior to the effective date of said Act, by statute, by the respective Orders of Appointment and any subsequent Orders.

All full-time employees employed by said United States Commissioners and paid by the United States are hereby continued in their respective offices and positions for the United States District Court, Northern District of California, Northern Division, for the purpose of performing such duties as may devolve upon them for the Northern District of California, Northern Division, as it existed prior to the effective date of said Act, by statute, by the respective Orders of Appointment and any subsequent Orders.

In the event individual appointments may be required, such appointments will be effective as of the effective date of said Act.
