### Position Overview

The court is seeking applicants for a full-time, one year term law clerk position in our Sacramento office. The incumbent will assist Chief Judge Morrison C. England, Jr. by conducting substantive review, research and writing on a wide range of issues that arise in federal litigation. The position is available with an immediate start date of employment.

### Minimum Qualifications

For consideration, applicants must be law school graduates with excellent academic records. Applicants also must possess at least two years of post-graduate legal work experience in a high-volume, production oriented work environment. Federal clerkship experience is preferred.

For appointment at a JSP grade 11 step 1 (currently \$62,686), an applicant must be a law school graduate and have the equivalent of one year of full-time legal work experience after graduation from law school. Substitutions for the one year include:

- Graduation in the upper third of a law school class;
- Experience on the editorial board of a law review; publication of a noteworthy article in a law school student or scholarly publication;
- Special high-level honors for academic excellence in law school, such as election to the Order of the Coif;
- Winning of a moot court competition or membership on a moot court team that represents the law school in competition with other law schools; participation in the legal aid or other law school clinical program;
- Or summer experience as a law clerk to a state or local judge or law clerk experience on a continuous basis in a private firm while attending law school.

For appointment at a JSP grade 12 step 1 (currently \$75,136), an applicant must meet the qualifications for a JSP grade 11, possess one additional year of full-time legal work experience after graduation from law school (no substitutions permitted) AND be a member of the Bar of a state, territorial, or Federal Court of general jurisdiction.

For appointment at a JSP grade 13 step 1 (currently \$89,347), an applicant must meet the qualifications for a JSP grade 12 and possess at least one additional year of full-time legal work experience after graduation from law school (no substitutions permitted).
