U.S. Magistrate Judge Barbara A. McAuliffe is accepting applications for a term law clerk position in her chambers. The incumbent will conduct extensive research and writing on prisoner §1983 litigation pending before the judge.

The initial term of appointment will be two years and is subject to renewal for up to an additional two years. The candidate selected for the position will be expected to commence employment on or shortly after October 31, 2016.

MINIMUM QUALIFICATIONS

For consideration, applicants must be law school graduates with excellent academic records and excellent research and writing skills. Applicants must also possess one or more years of post graduate legal work experience in a high-volume, production oriented work environment. Additional years of work experience including federal clerkship experience and experience handling prisoner §1983 litigation are highly preferred. Starting salary will be set based on the following:

For appointment at a JSP grade 11 step 1 (\$59,246), an applicant must be a law school graduate and possess at least one year of full-time legal work experience after graduation from law school.

For appointment at a JSP grade 12 step 1 (currently \$71,012), an applicant must meet the qualifications for a JSP grade 11 AND be a member of the Bar of a state, territorial or Federal Court of general jurisdiction.

For appointment at a JSP grade 13 step 1 (currently \$84,443), an applicant must meet the qualifications for a JSP grade 12 and possess at least one additional year (i.e., two or more total years) of full-time legal work experience after graduation from law school
