- (c) Knowingly giving a false or fictitious report or other false information to an authorized person investigating an accident or violation of law or regulation; and MA
- (d) Knowingly giving a false report or false information for the purpose of misleading a government employee or agent in the conduct of official duties. MA

Prohibition of explosives.

Using, possessing, storing, or transporting explosives, blasting agents, or explosive materials is prohibited except as allowed by State and Federal law and as authorized by Reclamation. MA
