Payments are not accepted in Court. You must mail your payments to CVB, or make payment on the CVB website at www.cvb.uscourts.gov with credit, debit or checking account. If you are seeking an extension from a Court ordered fine, please be advised that **NO EXTENSIONS** are granted. In addition, you risk late penalties and referral to a collection agency. Traffic School

Abstracts / Arrest Warrants

To resolve your case if an abstract or arrest warrant has been issued against you, <u>pay your fine</u> or <u>request a new court date</u>. Your abstract or arrest warrant will NOT be released UNTIL all monetary penalties and fines imposed on you are PAID IN FULL.
