CVB FREQUENTLY ASKED QUESTIONS

Payments

Payments are not accepted in Court. You must mail your payments to CVB, or make payment on the CVB website at www.cvb.uscourts.gov with credit, debit or checking account. If you are seeking an extension from a Court ordered fine, please be advised that **NO EXTENSIONS** are granted. In addition, you risk late penalties. Contact CVB to ascertain late fees, etc., at 1-800-827-2982.

Traffic School

You may attend traffic school without making an appearance in Court. Send an email requesting traffic school to: SHall@caed.uscourts.gov or call 661-326-6624.

Abstracts / Arrest Warrants

To resolve your case if an abstract or arrest warrant has been issued against you, pay your fine or request a new court date. Your abstract or arrest warrant will NOT be released UNTIL all monetary penalties and fines imposed on you are PAID IN FULL.

New Court Date

The Court may grant one extension of time. For all subsequent requests for extensions of time, you must contact the agency that cited you, and stipulate to a new court date. The agency you must contact is identified on the top right corner of your violation notice, in the box titled *CVB Location Code*. Contact that prosecutor of that location code as set forth below:
