
Eight-hundred years ago in England the first effective and comprehensive system of laws was established. This document, the Magna Carta or Great Charter, was a major influence on the United States Constitution, and its key ideas still remain in our system of government. The "due process of law" ensures that every citizen of our nation has a right to a fair trial before being deprived of life, liberty, or property.

If I were to set up a government, I would model it after America's current system. The United States government is very stable, and has a global reputation of protecting the rights of its people.
