7                   Pursuant to the Jury Selection and Service Act of 1968, as  
8 amended (28 U.S.C. § 1861, et seq.), the following Amendment to  
9 the Amended Plan filed March 11, 1992, is hereby adopted by this  
10 Court, subject to approval by the reviewing panel for the Ninth  
11 Circuit and to such rules and regulations as may be adopted from  
12 time to time by the Judicial Conference of the United States:

15                   AMENDMENT TO ARTICLE V JURY SELECTION SOURCE

16  
17                   Article V Jury Selection Source is amended by adding thereto  
18 the following:

19                   To facilitate broadening the source from which the  
20 names of petit and grand jurors shall be selected at  
21 random, a pilot project shall be implemented in the  
22 Fresno Division, utilizing State of California,  
23 Department of Motor Vehicles records from all counties  
24 within the Fresno Division to augment names from which  
25 petit and grand jurors shall be selected. This juror  
26 source pilot project shall commence when the Clerk is  
27 notified by the California Department of Motor Vehicles  
28 that names of prospective jurors can be provided and

1 the computer software is available and operative to  
2 permit implementation and management of this juror  
3 source supplementation.

4 Names of petit and grand jurors as supplemented by  
5 California DMV records selected at random, shall be  
6 included in the overall source of prospective jurors in  
7 the Fresno Division and processed in accordance with  
8 the remaining requirements for initial selection of  
9 names for the master wheel method and in the manner of  
10 random selection as prescribed in the Articles of the  
11 existing Amended Jury Selection Plan of the Eastern  
12 District of California, to be applied and implemented  
13 in the Fresno Division.

14 This pilot project in the Fresno Division to  
15 supplement the source of prospective juror names from  
16 California DMV records shall continue in force and  
17 effect for such a period of time as shall permit  
18 thorough evaluation of the ability of such  
19 supplementation plan to accomplish its purposes.
