crime was committed on Tribal land. This case was brought to the Supreme Court where they were asked the question about Native American sovereignty. The Supreme Court tackled the question of which lands promised to the natives are still sovereign. The case ended in a 5 to 4 vote saying that the land promised to the natives was still their land and will be recognized as such.

McGirt was returned back to the Seminole Tribe Reservation where he was tried by their court and found guilty of his crimes. He now serves life imprisonment with no hope of parole. Many are happy to know that Jimcy McGirt will never harm a child again but this could have been an easier conclusion from the start if we had just turned him to the Tribal Court first. The United States has had problems with identifying Native Nations before and it has brought us legal trouble throughout history.

Our relationship with Native Nations is what is keeping us from a more perfect union.

Many times we have failed to recognize Reservations all together. The Federal Government has created plans to build through Native Land in 2020 (now canceled) without consulting the Native Americans first. Nowadays we do not issue any more treaties to Native Americans, leaving their numbers dwindling. Not all is bad though, in turn we give those recognized reservations protection and healthcare, they get their own laws and legal systems as well. If we could change to a more cohesive relationship with those who we share our country with, we would make great strides to a more perfect union.

We are not where we used to be and that is progress but we are certainly not where we need to be. Everyday Americans work toward our goals and securing a healthy future.
